COVID Precautions

The Board of Women LISTEN is excited to resume this yearly fly-fishing event and we request all participants to join in the following precautions to keep everyone healthy during the event.

- People with cancer may be at higher risk of serious illness. Check with your health care provider before registering if you have any concerns for your own health as you take part in this group experience.
- Even if you are chosen to attend, you may wake up on Saturday morning experiencing Covid-19 symptoms, or, you might find out that in the last 10 days you've been exposed to Covid-19 or received a positive test result yourself. Please let us know ASAP that you won't be coming. Another woman may be able to take your place. We will miss you.
- Each participant is encouraged to make their own decisions about wearing a mask indoors and outdoors during the day. Social distancing options will also be available. Hand sanitizer and extra masks will be provided. Hand washing facilities are on site.

Attached to this page are two documents that need to be filled out and returned to me at the address listed below. If you experience any difficulty, please call for assistance. I will look forward to receiving your completed forms. Once I receive these forms, they will be given to retreat staff members who will screen and select all participants according to the following guidelines:

Applications will be reviewed, and preference will be given to:

- 1. Women who have had a cancer diagnosis and have attended Women LISTEN group meetings held on Fridays on Zoom from 10 11:30 AM and who have never attended the fly-fishing retreat previously.
- 2. Women who have had a cancer diagnosis but have never attended Women LISTEN group meetings.
- 3. Women who have previously attended a fly-fishing retreat may apply for the retreat, but they may only be accepted if fewer than 10 women from the top two priority groups do not fill the designated spots.

Retreat Description The retreat is available free of charge to women who have had a diagnosis of any cancer. The One-Day Retreat (no overnight activities) will be limited to 10 women. Retreat facilities are rustic. You can see additional information about the lodge on Facebook at https://www.facebook.com/beachlakelodge/. Come prepared to have an enjoyable, very active, fun filled day packed with laughter and information as you build your support and empowering network through talking and fly-fishing activities. We have fishing gear including float tubes, fins, rods, reels, waders, etc., with a wide variety of sizes that will fit most women.

Applications will be reviewed as soon as possible after submission, and I will contact you to inform you about your acceptance. If 10 individuals are accepted prior to the deadline date, you will be contacted to determine if you want to be on a waitlist. If you have any questions about the screening process, please feel free to contact me.

After you are accepted for the retreat, I will forward additional information to you about the retreat and directions to the retreat lodge, the retreat schedule, and clothing and other items to bring along to the retreat.
